## GENERAL CONDITIONS OF SALE

### Terms of Service

For all invoices, payment must be made via EFT and invoice number must be used as bank reference. Details will be emailed with the invoice. In the case where you have stored your credit card on file with us, you will be charged automatically after 7 days of auction close without prior notification. There will be a charge of 5% levied on all such card payments.

A Buyers premium of 20% and sellers premium 10% will be charged for Consignment fees on all transactions completed by Bassani's Auction House.

All items will be shipped to the buyer's address on file, only after full payment has been received. For security reasons, no collection of goods will be entertained.

Your signature or acceptance from the Courier acknowledges the receipt of the delivered goods detailed on the invoice. Furthermore, you acknowledge that delivered goods underwent proper inspection and are without any undisclosed defect.

If you have won an auction item that you no longer wish to buy (buyer's remorse), we do allow members to cancel their purchase(s) by paying a restocking fee for each lot they want to be cancelled (unless stated otherwise in listing comments). This fee is 50% (minimum R250 charge) of the sale price of the item(s) being restocked. Where no payment has been received after 7 days, you agree that we will accept this as buyer's remorse.

If your account is deactivated for non-payment of restocking fees, we will not be able to reactivate your account until all monies owing are paid in full. **You bind yourself personally to Bassani's Auctioneers for such account fees and agree to pay all legal and collections fees that may arise.**
